A. Certification

1. Preliminary Remarks

Under the BSIG¹ Act, the Federal Office for Information Security (BSI) has the task of issuing certificates for information technology products.

Certification of a product is carried out on the instigation of the vendor or a distributor, hereinafter called the sponsor.

A part of the procedure is the technical examination (evaluation) of the product according to the security criteria published by the BSI or generally recognised security criteria.

The evaluation is normally carried out by an evaluation facility recognised by the BSI or by BSI itself.

The result of the certification procedure is the present Certification Report. This report contains among others the certificate (summarised assessment) and the detailed Certification Results.

The Certification Results contain the technical description of the security functionality of the certified product, the details of the evaluation (strength and weaknesses) and instructions for the user.

2. Specifications of the Certification Procedure

The certification body conducts the procedure according to the criteria laid down in the following:

- Act on the Federal Office for Information Security¹
- BSI Certification and Approval Ordinance²
- BMI Regulations on Ex-parte Costs³
- Special decrees issued by the Bundesministerium des Innern (Federal Ministry of the Interior)
- DIN EN ISO/IEC 17065 standard
- BSI certification: Scheme documentation describing the certification process (CC-Produkte) [3]
- BSI certification: Scheme documentation on requirements for the Evaluation Facility, its approval and licencing process (CC-Stellen) [3]

3. Recognition Agreements

In order to avoid multiple certification of the same product in different countries a mutual recognition of IT security certificates - as far as such certificates are based on ITSEC or CC - under certain conditions was agreed.

3.1. European Recognition of CC – Certificates (SOGIS-MRA)

The SOGIS-Mutual Recognition Agreement (SOGIS-MRA) Version 3 became effective in April 2010. It defines the recognition of certificates for IT-Products at a basic recognition level and, in addition, at higher recognition levels for IT-Products related to certain SOGIS Technical Domains only.

The basic recognition level includes Common Criteria (CC) Evaluation Assurance Levels EAL 1 to EAL 4. For "Smartcards and similar devices" a SOGIS Technical Domain is in place. For "HW Devices with Security Boxes" a SOGIS Technical Domains is in place, too. In addition, certificates issued for Protection Profiles based on Common Criteria are part of the recognition agreement.

The current list of signatory nations and approved certification schemes, details on recognition, and the history of the agreement can be seen on the website at <https://www.sogis.eu>.

The SOGIS-MRA logo printed on the certificate indicates that it is recognised under the terms of this agreement by the related bodies of the signatory nations. A disclaimer beneath the logo indicates the specific scope of recognition.

This certificate is recognized under SOGIS-MRA for all assurance components selected.

3.2. International Recognition of CC – Certificates (CCRA)

The international arrangement on the mutual recognition of certificates based on the CC (Common Criteria Recognition Arrangement, CCRA-2014) has been ratified on 08 September 2014. It covers CC certificates based on collaborative Protection Profiles (cPP) (exact use), CC certificates based on assurance components up to and including EAL 2 or the assurance family Flaw Remediation (ALC_FLR) and CC certificates for Protection Profiles and for collaborative Protection Profiles (cPP).

This certificate is recognized according to the rules of CCRA-2014, i. e. up to and including CC part 3 EAL 2.

4. Performance of Evaluation and Certification

The certification body monitors each individual evaluation to ensure a uniform procedure, a uniform interpretation of the criteria and uniform ratings.

The product cryptovision SMAERS, Version 2.0 has undergone the certification procedure at BSI.

The evaluation of the product cryptovision SMAERS, Version 2.0 was conducted by TÜV Informationstechnik GmbH. The evaluation was completed on 30 March 2023. TÜV Informationstechnik GmbH is an evaluation facility (ITSEF)⁵ recognised by the certification body of BSI.

For this certification procedure the sponsor and applicant is: cv cryptovision GmbH.

The product was developed by: cv cryptovision GmbH.

The certification is concluded with the comparability check and the production of this Certification Report. This work was completed by the BSI.

5. Validity of the Certification Result

This Certification Report applies only to the version of the product as indicated. The confirmed assurance package is valid on the condition that

- all stipulations regarding generation, configuration and operation, as given in the following report, are observed,
- the product is operated in the environment described, as specified in the following report and in the Security Target.

For the meaning of the assurance components and assurance levels please refer to CC itself. Detailed references are listed in part C of this report.

The Certificate issued confirms the assurance of the product claimed in the Security Target at the date of certification. As attack methods evolve over time, the resistance of the certified version of the product against new attack methods needs to be re-assessed. Therefore, the sponsor should apply for the certified product being monitored within the assurance continuity program of the BSI Certification Scheme (e.g. by a re-assessment or re-certification). Specifically, if results of the certification are used in subsequent evaluation and certification procedures, in a system integration process or if a user's risk management needs regularly updated results, it is recommended to perform a re-assessment on a regular e.g. annual basis.

In order to avoid an indefinite usage of the certificate when evolved attack methods would require a re-assessment of the products resistance to state of the art attack methods, the maximum validity of the certificate has been limited. The certificate issued on 27 April 2023 is valid until 26 April 2031. Validity can be re-newed by re-certification.

1. when advertising the certificate or the fact of the product's certification, to refer to the Certification Report as well as to provide the Certification Report, the Security Target and user guidance documentation mentioned herein to any customer of the product for the application and usage of the certified product,
2. to inform the Certification Body at BSI immediately about vulnerabilities of the product that have been identified by the developer or any third party after issuance of the certificate,
3. to inform the Certification Body at BSI immediately in the case that security relevant changes in the evaluated life cycle, e.g. related to development and production sites or processes, occur, or the confidentiality of documentation and information related to the Target of Evaluation (TOE) or resulting from the evaluation and certification procedure where the certification of the product has assumed this confidentiality being maintained, is not given any longer. In particular, prior to the dissemination of confidential documentation and information related to the TOE or resulting from the evaluation and certification procedure that do not belong to the deliverables according to the Certification Report part B, or for those where no dissemination rules have been agreed on, to third parties, the Certification Body at BSI has to be informed.
4. to conduct a re-assessment or re-certification after 5 years (i.e. the re-assessment must be finalized before 26 April 2028 in order to assess the robustness of the product against new state-of-the-art attack methods. This has to be done on the developer's own initiative and at his own expense. As evidence a report regarding a re-assessment or a re-certification according to the regulations of the BSI certification scheme shall be provided.
5. to use the CSP module identified in BSI-DSZ-CC-1119-2023 as underlying CSP for the present SMAERS TOE.

In case of changes to the certified version of the product, the validity can be extended to the new versions and releases, provided the sponsor applies for assurance continuity (i.e. re-certification or maintenance) of the modified product, in accordance with the procedural requirements, and the evaluation does not reveal any security deficiencies.

6. Publication

B. Certification Results

The following results represent a summary of

- the Security Target of the sponsor for the Target of Evaluation,
- the relevant evaluation results from the evaluation facility, and
- complementary notes and stipulations of the certification body.

1. Executive Summary

The Target of Evaluation (TOE) is named cryptovision SMAERS – Java Card applet providing Security Module Application for Electronic Record-keeping Systems and was evaluated in version 2.0. It is a security module application implemented as software running on the cryptovision CSP (cryptographic service provider). The TOE is a part of the security module of a certified technical security system (CTSS) for electronic record-keeping systems (ERS).

The Security Target [6] is the basis for this certification. It is based on the certified Protection Profile Common Criteria Protection Profile Security Module Application for Electronic Record-keeping Systems (SMAERS) Version 1.0, 15 July 2020, BSI-CC-PP-0105-V2-2020 [8].

The ST also lists TSF_CSP, however this Security Functionality is not part of the TOE as it is provided solely by the underlying CSP platform (BSI-DSZ-CC-1119-2022). The Security Target [6] has identified solely one configuration of the TOE under evaluation.

The TOE Security Assurance Requirements (SAR) are based entirely on the assurance components defined in Part 3 of the Common Criteria (see part C or [1], Part 3 for details). The TOE meets the assurance requirements of the Evaluation Assurance Level EAL 2 augmented by ALC_LCD.1 and ALC_CMS.3.

The TOE Security Functional Requirements (SFR) relevant for the TOE are outlined in the Security Target [6], chapter 6. They are all selected from Common Criteria Part 2. Thus the TOE is CC Part 2 conformant.

The TOE Security Functional Requirements are implemented by the following TOE Security Functionality:

The assets to be protected by the TOE are defined in the Security Target [6], chapter 3. Based on these assets the TOE Security Problem is defined in terms of Assumptions, Threats and Organisational Security Policies. This is outlined in the Security Target [6], chapter 3.

This certification covers the configurations of the TOE as outlined in chapter 8.

The vulnerability assessment results as stated within this certificate do not include a rating for those cryptographic algorithms and their implementation suitable for encryption and decryption (see BSI Section 9, Para. 4, Clause 2).

The certification results only apply to the version of the product indicated in the certificate and on the condition that all the stipulations are kept as detailed in this Certification Report. This certificate is not an endorsement of the IT product by the Federal Office for Information Security (BSI) or any other organisation that recognises or gives effect to this

certificate, and no warranty of the IT product by BSI or any other organisation that recognises or gives effect to this certificate, is either expressed or implied.

2. Identification of the TOE

Regarding delivery:

The TOE cryptovision SMAERS consists of two Java Card Applets, the SMAERSD and the SMAERSI. First, the TOE is delivered by encrypted e-mail from cryptovision to NXP or a third party. There the applications are integrated on the certified cryptovision CSP. In addition, the guidance documentation [11] and [12] is delivered by encrypted e-mail from cryptovision to NXP or a third party. This is the delivery in sense of Common Criteria. Afterwards the product is delivered integrated on the certified cryptovision CSP to the customer. The Security Target [6] outlines the delivery procedure.

In addition, cryptovision delivers the guidance documents [11] and [12] directly, via signed and encrypted e-mail, to the customer.

Regarding identification:

The documents [11] and [12] contain the identification procedure for the TOE.

3. Security Policy

The Security Policy is expressed by the set of Security Functional Requirements and implemented by the TOE. It covers the following issues:

- User Data Protection,
- Identification and Authentication,
- Security Management,
- Security Audit,
- Protection of the TSF and
- Code Update Package import.

Specific details concerning the above mentioned security policies can be found in the Security Target [6] chapter 6.1.

4. Assumptions and Clarification of Scope

The Assumptions defined in the Security Target and some aspects of Threats and Organisational Security Policies are not covered by the TOE itself. These aspects lead to specific security objectives to be fulfilled by the TOE-Environment. The following topics are of relevance:

- OE.ERS Trustworthy electronic record-keeping system,
- OE.CSP Cryptographic service provider component,

- OE.CSPPlatform CSP as secure platform of the TOE,
- OE.SMAERSPlatform as Secure platform storage,
- OE.Transaction Verification of Transaction,
- OE.SecOEnv Secure operational environment,
- OE.SecCommCSP Secure communication between TOE and CSP and
- OE.SUCP Signed Update Code Packages, and
- OE.SecUCP.

Details can be found in the Security Target [6], chapter 4.2.

5. Architectural Information

The TOE cryptovision SMAERS consists of two Java Card application, the SMAERSD and SMAERSI. It runs on the to be certified cryptovision CSP and comprises the following subsystems:

- Command Processor: Provides the main interface to the TOE and takes the decision which command will be executed by the appropriate subsystem, or that the APDU is rejected due to an unavailable instruction code.
- Configuration Manager: Provides services for application creation in terms of applet instantiation.
- User Manager: Initially creates the configured users like Admin and TimeAdmin as well as the roles CTSS and CSP for creation of transaction and system logs. Furthermore, it handles user authentication and changing reference data by using CSP functions, and returns status information on request.
- Transaction Manager: Provides services for signing transaction logs using CSP functions.
- System Log Manager: Uses CSP functions to create logs for system events such as user authentication or setting of system time.
- Data Container: Stores configuration data and is used to persist data generated during runtime.

6. Documentation

The evaluated documentation as outlined in table 2 is being provided with the product to the customer. This documentation contains the required information for secure usage of the TOE in accordance with the Security Target.

Additional obligations and notes for secure usage of the TOE as outlined in chapter 10 of this report have to be followed.

7. IT Product Testing

Developer's testing approach:

The developer considered the following aspects when designing his test approach:

- Tests to cover all TSFI defined in developer documents,

- Good case and bad case tests for each interface defined in the respective developer document and executable on the TOE,
- Tests covering all TSF subsystems in the TOE design.

Verdict for the activity:

All test cases in each test suite were run successfully on this TOE version.

The developer's testing results demonstrate that the TOE operates as expected.

Evaluator tests (ATE_IND):

Independent testing according to ATE_IND was conducted.

The TOE was tested in the one configuration in scope of the certification.

The test results have not shown any deviations between the expected test results and the actual test results.

Evaluator tests (AVA):

Penetration testing according to AVA was also conducted.

The overall test result is that no deviations were found between the expected and the actual test results. No attack scenario with the attack potential 'Basic' was actually successful in the TOE's operational environment as defined in [6] provided that all measures required by the developer are applied.

The test results have not shown any deviations between the expected test results and the actual test results.

8. Evaluated Configuration

The evaluated TOE configuration is identical with the one described in table 2, which in turn is the delivered product. There is only one configuration of the TOE. For all tests the TOE is configured and parameterized, if necessary, according to the guidance documents. The cryptovision SMAERS TOE configuration is loaded and installed on the underlying CSP platform. The cryptovision SMAERS TOE needs to be installed and personalised according to the guidelines given in [11] and [12].

9. Results of the Evaluation

9.1. CC specific results

The Evaluation Technical Report (ETR) [7] was provided by the ITSEF according to the Common Criteria [1], the Methodology [2], the requirements of the Scheme [3] and all interpretations and guidelines of the Scheme (AIS) [4] as relevant for the TOE.

The Evaluation Methodology CEM [2] was used.

The following guidance specific for the technology was considered (while not being mandatory during the CC certification and not being evaluated according to):

- (i.) TR_03151 Technical Guideline BSI TR-03151 Secure Element API (SE API), BSI, Version 1.0.1, 20. December 2018,
- (ii.) TR_03153 Technische Richtlinie BSI TR-03153 Technische Sicherheitseinrichtung für elektronische Aufzeichnungssysteme, BSI, Version 1.0.1, 20. Dezember 2018.

The assurance refinements outlined in the Security Target were followed in the course of the evaluation of the TOE.

As a result of the evaluation the verdict PASS is confirmed for the following assurance components:

- All components of the EAL 2 package (augmented by ALC_LCD.1 and ALC_CMS.3) including the class ASE as defined in the CC (see also part C of this report)

The evaluation has confirmed:

- PP Conformance: Common Criteria Protection Profile Security Module Application for Electronic Record-keeping Systems (SMAERS) Version 1.0, 15 July 2020, BSI-CC-PP-0105-V2-2020 [8]
- for the Functionality: PP conformant
Common Criteria Part 2 conformant
- for the Assurance: Common Criteria Part 3 conformant EAL 2 (augmented by ALC_LCD.1 and ALC_CMS.3).

For specific evaluation results regarding the development and production environment see annex B in part D of this report.

The results of the evaluation are only applicable to the TOE as defined in chapter 2 and the configuration as outlined in chapter 8 above.

9.2. Results of cryptographic assessment

The TOE does not include cryptographic mechanisms as a service. The only cryptographic mechanism used are implemented in the CSP platform or the Java Card platform and not part of this evaluation. Thus, no such mechanisms were part of the assessment.

10. Obligations and Notes for the Usage of the TOE

The documents as outlined in table 2 contain necessary information about the usage of the TOE and all security hints therein have to be considered. In addition all aspects of Assumptions, Threats and OSPs as outlined in the Security Target not covered by the TOE itself need to be fulfilled by the operational environment of the TOE.

As the TOE relies on security functionality provided by the underlying CSP, it must be operated in conjunction with the CSP of the evaluated configuration. For details concerning the CSP and its certification refer to the certification procedure BSI-DSZ-CC-1119-2022 and the dedicated BSI Report [21].

In regard of the further operational environment, it is to be noted that the certification and evaluation were conducted under the condition, that the objective for the operational environment “OE.SecOEnv: Secure operational environment” (Security Target [6]) is in place. In detail, the objective states:

OE.SecOEnv: Secure operational environment:

The operational environment shall protect the electronic record-keeping system and the certified technical security system including the TOE against manipulation, perturbation and misuse. It protects the integrity of the communication between the electronic record-keeping system and the TOE.

The customer or user of the product shall consider the results of the certification within his system risk management process. In order for the evolution of attack methods and techniques to be covered, he should define the period of time until a re-assessment of the TOE is required and thus requested from the sponsor of the certificate.

The limited validity for the usage of cryptographic algorithms needs to be considered for the intended TOE usage, it has to be considered by the user and his system risk management process.

Also note that the UCP (Update Code Package) mechanism itself is certified according to this certificate's evaluation assurance level and the respective Security Target's Security Functional Requirements. However, installation and usage of other TOE configuration items than specified in the Security Target ([6]) (and thus evaluated during the course of this certification) are not included in this certificate. Recertifications are required in order to maintain a valid certification status in cases where such TOE changes are to be applied. As a consequence, only certified updates of the TOE should be used via a respective UCP deployment procedure. If non-certified Update Code Packages are available, TOE user discretion is advised on whether the sponsor should provide a re-certification. In the meantime a risk management process of the system using the TOE should investigate and decide on the usage of not yet certified updates and patches or take additional measures in order to maintain system security.

Regarding Public Key Infrastructure (PKI) it is to be noted, that neither the Protection Profile [8] nor the Security Target ([6]) address (security-assurance- or security-functional) requirements concerning a PKI. Therefore, no PKI aspects were CC evaluated by the ITSEF or the BSI CC certification Section in the course of the underlying CC evaluation. Hence the CC certification scope does not cover the Public Key Infrastructure. However, the developer cv cryptovision GmbH provided a (confidential) PKI concept document [17], outlining relevant PKI structures, definitions and processes. The document was examined by a dedicated BSI Section and deemed suitable.

Similar as for the PKI concept document, the Protection Profile requires additional documentation, which also were not evaluated by the ITSEF or the BSI CC certification Section during the CC evaluation and the CC certification procedure but were examined by a dedicated BSI Section and deemed suitable:

- The provisioning of the CSP within the life cycle of the CTSS describing the initial personalization and subsequent renewal of keying material used in the context of the TOE, the assignment and separation of users and roles contained in the CSP, and the audit configuration of the CSP,
- The update procedures to allow for recovery from security incidents including the procedures for creating, distributing, and enforcing installation of update code packages for the TOE and the CSP.
- The "Umgebungsschutzkonzept SMAERS v2" [20].

For all respective documents see [17], [18], [19] and [20].

The TOE includes guidance documentation (see table 2) which contains obligations and guidelines for the user and/or developer of the product layer on top on how to securely use this certified TOE and which measures have to be taken in order to fulfil the overall security requirements of the Security Target of the TOE.

If the TOE is subject to an evaluation in a composite product or system, it must be examined if the required measures have been correctly and effectively implemented by the product layer on top.

At the point in time when evaluation and certification results are reused, there might be an updated documentation available. Therefore, the certified products list on the BSI website has to be checked for latest information on reassessments, recertifications or maintenance result available for the product.

13.2. Glossary

Augmentation - The addition of one or more requirement(s) to a package.

Collaborative Protection Profile - A Protection Profile collaboratively developed by an International Technical Community endorsed by the Management Committee.

Extension - The addition to an ST or PP of functional requirements not contained in CC part 2 and/or assurance requirements not contained in CC part 3.

Formal - Expressed in a restricted syntax language with defined semantics based on well-established mathematical concepts.

Informal - Expressed in natural language.

Object - A passive entity in the TOE, that contains or receives information, and upon which subjects perform operations.

Package - named set of either security functional or security assurance requirements

Protection Profile - A formal document defined in CC, expressing an implementation independent set of security requirements for a category of IT Products that meet specific consumer needs.

Security Target - An implementation-dependent statement of security needs for a specific identified TOE.

Semiformal - Expressed in a restricted syntax language with defined semantics.

Subject - An active entity in the TOE that performs operations on objects.

Target of Evaluation - An IT Product and its associated administrator and user guidance documentation that is the subject of an Evaluation.

TOE Security Functionality - Combined functionality of all hardware, software, and firmware of a TOE that must be relied upon for the correct enforcement of the SFRs.
